Professor A. Uwiyono

Professor Uwiyono is Professor of Labor Law at the University of Indonesia. He is research areas include *Legal Aspects of Indonesian Migrant Workers*, *The Role of Labor Law in the Globalization Era*, and *The Right to Strike in Indonesia*.
