Decentralization Policies in Indonesia, 1999-2003: A Chronological List of Laws and Regulations with Introductory Guide

Section 1: INTRODUCTORY GUIDE TO SECTION 2

Since the collapse of the “New Order” regime, an explicit aspiration to promote decentralization has grown among the people in Indonesia. The first step done by the new government in order to fulfill the aspiration was stipulating the “implementation of regional autonomy,” “just coordination, distribution and utilization of national resources” and “fiscal balancing between central and regional governments” in the Resolution No. XV of the Special Session of the People’s Consultative Assembly (*Majelis Permusyawaratan Rakyat*) in 1998.

In May of 1999, two basic laws (*Undang-Undang*) on regional autonomy, namely Law on Regional Administration (Law No. 22) and Law on Fiscal Balancing between Central and Regional Governments (Law No. 25) were promulgated. Thereafter a lot of regulations (*peraturan*), decrees (*keputusan*) and instructions (*instruksi*) in support of the two laws were issued. Recommendations for strengthening of regional autonomy were stipulated both in the State Policy Guidelines (*Garis-Garis Besar Haluan Negara*) 1999-2004: the Resolution No. IV of the General Session of the People’s Consultative Assembly in year 1999, and in Resolution No. IV of the Annual Session of the People’s Consultative Assembly in year 2000.

What kinds of laws, regulations and decrees were promulgated to support the two basic laws between 1999 and 2003? A list of them that covers ministerial decrees and over is recorded in Section 2. The first section provides a broad explanation of them by year following the law hierarchy in Indonesia.

Year 1999

One month before the promulgation of the two basic laws, eight laws covering Law No. 9 to Law No. 16 concerning the formation of new regencies and municipalities had been issued. The other formations of new regencies/municipalities in this year were regulated in Law No. 45 to No. 55. In August, a law regulating the legal status of Jakarta Special Capital Region (No. 34) was promulgated. In September followed the new forestry law (No. 41) that is closely related to Law No. 22/1999. Law No. 44 explained the specific state policies of the Special Region of Aceh in the fields of religion, customary law, education, etc.

Formation of new sub-districts (*kecamatan*) (No. 20 to No. 22, No. 42 to 50), transfer of regency capital (No. 70, No. 71), change of name of municipality (No. 86) were regulated in Government Regulations (*Peraturan Pemerintah*) before the end of Habibie administration.

Presidential Decree No. 67 is about a Coordinating Team for the implementation of the two basic laws dealing with the composition of the team and its duties.

Regulation of the Minister of Home Affairs (*Peraturan Menteri Dalam Negeri*) No. 4 was issued for the following reformation of village (*desa*) and county (*kelurahan*) administration systems.

Decrees of the Minister of Home Affairs (*Keputusan Menteri Dalam Negeri*) regulate management of local tax, levies and enterprises, population registration, village administration, county formation, local assemblies, organization and functions of the Department of Home Affairs, etc. as guidelines for local officials.

Many of the Decrees of the Minister of Finance (*Keputusan Menteri Keuangan*) were on allotment methods of Land and Building Tax (*Pajak Bumi dan Bangunan*) between central and regional governments.

Year 2000

Law No. 5 to No. 15 are modified versions of Law No. 45 to No. 55, Year 1999 each, in which the way to determine local representative seats were changed. Law No. 23, No. 27 and No. 38 are about the formation of new provinces. Law No. 34 deals with revisions of local tax and levies setting.

Government Regulations of this year deal a lot of dimensions, like transfer of regency capitals (No. 15, No. 62), allotment methods of Land and Building Tax (No. 16), delineation of authority between central and provincial government (No. 25), regional organizations (No. 84), fiscal status of local heads (No. 109), fiscal status of local assemblies (No. 110), requirements for establishment, abolition and merger of regional governments (No. 129), and method of selecting, determining and discharging local heads/vice heads (No. 151). In financial sectors, they also regulate a lot, such as fund balancing (No. 104), local loans (No. 107), allotment of income tax, and so on.

Several Presidential Decrees in this year deal with Regional Autonomy Advisory Council (DPOD) (No. 49, No. 84, No. 151), organization of the Coordination Team in charge for the enforcement of the two basic laws (No. 52), local assembly seats (No. 110), organization of Central Working Committee for implementing the two basic laws (No. 157), and the allotment of General Allocation Fund (*Dana Alokasi Umum*) (No. 181).

Decrees of the Minister of Home Affairs in this year regulate guidelines for candidacy, election, confirmation, and dismissal of local head/vice head (No. 2), criteria on sub-district formation (No. 4), formation of regional government associations (No. 16), selection of local representatives as members of the Regional Autonomy Advisory Council (No. 19), management of local enterprise (No. 30), etc.

Decrees of the Minister of Home Affairs and Regional Autonomy (*Keputusan Menteri Dalam Negeri dan Otonomi Daerah*) regulate local assemblies (No. 35, No. 36), management of local bank (No. 44 to No. 46), management of official documents of regional governments (No. 47, No. 48), and organization and working system of regency/municipal apparatus (No. 50), as well as formation of the Central Working Team for the acceleration of implementation of the two basic laws (No. 188.2-198).

In this year, many decrees of the Minister of Finance were issued to arrange the Land and Building Tax and its allotment method.

Year 2001

Entering the first year of decentralization, many important bills were adopted in the Parliament (DPR). First of all, two kinds of Special Autonomy laws on Aceh (No. 18) and Papua (No. 21) were promulgated. In these laws, local customs and institutions were very much valued and large part of income from natural resources was decided for the benefit of the concerned regional governments. Following the year 1999 and 2000, formation of new regional governments continues giving birth to 12 new municipalities (No. 2 to No. 13).

Important Government Regulations were also born on local assemblies (No. 1), report on local finance (No. 11), de-concentration (No. 39), supporting tasks (No. 52), report on local administration (No. 56), local taxes (No. 65), local levies (No. 66), harbor management (No. 69), airport management (No. 70), and guidelines for village administration (No. 76).

Presidential Decrees in this year regulate management of local hospitals (No. 40), food security (No. 41), local autonomy inspection (No. 74), as well as direction of contingency fund for transfer of civil servants and turnover of properties (No. 39), and allotment of General Allocation Fund for fiscal year 2002 (No. 131).

Plenty of Decrees of the Minister of Home Affairs and Regional Autonomy and later on, Decrees of the Minister of Home Affairs were issued especially in the form of guidelines and directives on various fields and amendments to previous decrees.

Decrees of the Minister of Finance deal with local loan, information system of local finance, contingency fund, etc.

Year 2002

All of the laws promulgated in this year are related to the establishment of new provinces, regencies and municipalities. While Law No. 4 to No. 13 regulate the formation of 19 regencies and three municipalities, Law No. 25 to No. 27 regulate the formation of one province, 14 regencies and one municipality.

Government Regulations deal with name change of a regency in East Kalimantan Province (No. 8), Land and Building Tax (No. 25), forest management (No. 34), Reforestation Fund (*Dana Reboisasi*) (No. 35), taxes from non-Marine and Fishery Department (No. 62), management of urban forests (No. 63), etc.

Two of the Presidential Decrees are related to the establishment of religious courts in new regional governments (No. 11, No. 62) and the other three regulate the establishment of new public prosecutors' offices (No. 13, No. 30, No. 74). Two Presidential Instructions of this year deal with Aceh problem (No. 1) and development promotion of the eastern part of Indonesia (No. 7).

Many of the Decrees of the Minister of Home Affairs regulate technical matters, such as taxation, tax allotment and administration of villages, as well as repeal of local regulations that are inconsistent with existing laws.

Decrees of the Minister of Finance regulate the allotment of various taxes and funds from national resources to each of the regional governments. One of the decrees (No. 471/KMK.02/2002) listed up each regional government's share over the Special Allocation Fund (*Dana Alokasi Khusus*).

Year 2003

Most of the laws of this year also deal with the establishment of new regional governments (No. 1 to No. 11, No. 29 to No. 41). The only exception is Law No. 17 that regulates public finances of central and regional governments.

Government Regulations regulate the number of units in each regional government (No. 8), management of civil servants (No. 9), transfer of regency capitals (No. 18, No. 29), abolition of eight administrative municipalities (*ko-tifs*) (No. 33), and financial administrations like management of income taxes of workers (No. 5), and management of cumulative loans of regional governments (No. 23), etc.

Presidential Decrees deal with registration of ex-East Timorese (No. 25), lifting of civil emergency law in North Maluku Province (No. 27), enforcement of martial law in Nanggroe Aceh Darussalam Province (No. 28), establishment of local courts in newly established regencies/municipalities (No. 39, No. 89), and allotment of General Allotment Fund to each regional government (No.1, No. 109), etc.

Presidential Instruction No. 1 of this year was issued to accelerate the establishment of new provinces and regencies/municipality in Irian Jaya Province; however, it brought about large-scale resistance movements in Central Irian Jaya, putting on halt such policy. Other Instructions are related to economic recovery and development of post-conflict areas of Maluku and North Maluku provinces (No. 6), strategies of e-government development (No. 3), national strategy for science and technology development (No. 4), and post-IMF economic policies package (No. 5).

Decrees of the Minister of Home Affairs are related to authorization over the candidacy of a civil servant as a local head or a member of a local assembly, school for local officials, repeal of local regulations, taxations, etc.

Decree of the Minister of Finance regulate each regional government's share over the Balancing Fund (*Dana Perimbangan*) and the fund allotment for hiring new civil servants, transfer of foreign debts from central government to regional governments, postponement of local loans, etc.
