The aim of the Institute of Developing Economies (Aija Keizai Kenkyusho) is to conduct basic and comprehensive research on economic and related affairs in Asia and other areas which are on the road to development. It, thereby, will contribute to the promotion of economic cooperation and the improvement of trade relations between Japan and these areas, and, ultimately, toward the prosperity and welfare of the developing countries.

The Institute was founded in December 1958 as a nonprofit organization. In July 1960, it was recognized as a semi-governmental body by law.

As of June 1, 1995, the number of staff members was 254, of whom about two thirds are engaged in research (including 31 stationed overseas), with the rest employed as librarians, statisticians, or secretarial personnel.

The budget of the Institute for the fiscal year 1995/96 is estimated at US\$53.8 million of which 90% is subsidized by the government.

IDE Spot Survey intends to respond to the public demand by offering prompt and proper analyses of emerging problems in developing countries. The first issue, Investment Risk in post-Deng China was published in March 1995.
